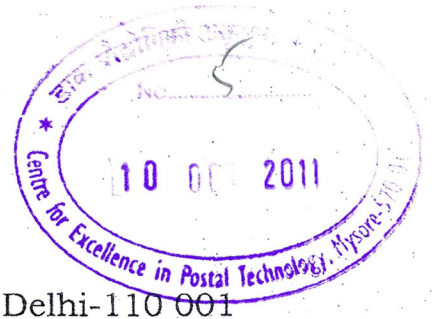

सा.का.नि. 717(अ).—राष्ट्रपति, संविधान के अनुच्छेद 309 के परंतुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए डाक विभाग (मल्टी टास्किंग स्टाफ) भर्ती नियम, 2010 को संशोधित करने के लिए निम्न नियम बनाते हैं, नामतः :—

1. (1) इन नियमों को डाक विभाग (मल्टी टास्किंग स्टाफ) (संशोधित) भर्ती नियम, 2011 कहा जाएगा।

(2) ये सरकारी राजपत्र में प्रकाशन की तारीख से प्रवृत्त होंगे।

2. डाक विभाग (मल्टी टास्किंग स्टाफ) भर्ती नियम, 2010 की अनुसूची में अधीनस्थ कार्यालय के मल्टी टास्किंग स्टाफ भाग-II से संबंधित क्रम संख्या 2 में, कालम (11) में प्रविष्टि (i) के बाद 'चयन-सह-वरिष्ठता' शब्दों के बाद निम्न प्रविष्टि जोड़ी जाए:—

'ऐसा न होने पर; चयन-सह-वरिष्ठता के आधार पर पड़ोसी डिवीजनों अथवा यूनिटों के ग्रामीण डाक सेवकों में से सीधी भर्ती द्वारा'।

New Delhi, the 26th September, 2011

G.S.R. 717(E)—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Department of Posts (Multi Tasking Staff) Recruitment Rules, 2010, namely :—

(1) These rules may be called the Department of Posts (Multi Tasking Staff) (Amendment) Recruitment Rules, 2011.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Schedule to the Department of Posts (Multi Tasking Staff) Recruitment Rules, 2010 against serial number 2 relating to Multi Tasking Staff Part II Posts of Subordinate Office, in Column (11), in entry (i) after the words 'Selection-Cum-seniority' the following entry shall be added :—

'failing which by; direct recruitment from amongst Gramin Dak Sevaks of the neighboring Divisions or Units on the basis of Selection-cum-seniority.'
