Sub: Results of the Examination for promotion of LGOs
to the cadre of PAs/SAs held on 16-10-2011.



The examination for promotion of LGOs to the cadre of PAs/SAs was held on Sunday, the 16th October, 2011. The examination was conducted by M/s CMC Ltd., New Delhi through outsourcing. The Directorate vide letter No. A-34013/01/2012-DE dated 23-01-2012 has forwarded the OMR answer sheets, tabulated sheet and combined merit list.

The Division wise information containing Names of successful candidates (arranged in the order of division wise merit) is shown in **Annexure-I**. In respect of bracketed candidates of Bangalore West and Gulbarga Division, the inter-se merit of the bracketed candidates may be fixed as per the Directorate instructions issued from time to time. Consequent to this, if there is change in the merit list, the same may be communicated to this office for issuing correction. The result is also available in the departmental website.

The selection of the candidates is based on the following eligibility criteria for qualifying in the examination:

OC Candidates	40% marks in each paper i.e 40/100 marks
SC/ST Candidates	33% marks in each paper i.e 33/100 marks

The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of information furnished by the Heads of Regional/Divisional office and units. In case there are any mistakes in the details of candidate(s), the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the selected candidate(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to any change in merit list of selected candidates for any reason in accordance with the existing rules and instructions on the subject. It may be **ensured that no provisional candidate is given appointment without regularisation of the candidature**. The Divisions/Regions are requested to verify the current status of the candidature of the qualified candidates before promoting the official. The officials /candidates against whom vigilance or disciplinary case is pending/those undergoing punishment should not be promoted and such cases should be referred back to this office.

The surplus merit list to the extent of unfilled UR vacancies is shown in **Annexure-II**. The details of Division wise unfilled OC vacancies are shown in **Annexure-III**. The Heads of Regions/Divisions/Units may take immediate action to call for the preference from the list of candidates in **Annexure-II** to give three preferences and sent to this office so as to reach by 29-02-2012. The candidates will be posted as far as possible according to the preference given by them. In the event of an official in the merit list of surplus passed candidates not willing to accept promotion in another division, the post will be offered to next official. It may be brought to the notice of such candidates that option given once is final and no withdrawal or change is allowed subsequently. Action will be initiated against such candidates as the entire exercise will become futile. Orders for filling up of **4 unfilled vacancies**, which are not filled in some divisions due to non availability of sufficient number of qualified candidates, will be issued by this office after receipt of options from the surplus qualified candidates through proper channel. **Allotment of surplus candidates will be purely on merit basis. The allotment of surplus candidates to other Division/Unit is subject to the following conditions**

1. that he/she will not be entitled for re-allotment to his parent division/unit after his/her promotion upto three years and
2. that he/she will not be repatriated to his parent division/unit even to his/her substantive post in the lower grade so long as he/she continues in the clerical cadre in the new division/unit.

A written declaration from the officials concerned in this regard may be obtained and kept on record and compliance reported to this office.

The unfilled SC/ST vacancies will be filled up only after completion of process of review of failed candidates in the concerned Division and from surplus SC/ST candidates, if any vacancies are still left unfilled after the review.

Since, the examination has been conducted through outsourcing using OMR answer sheets, the **request for re-totaling/revaluation will not be entertained.** Photo copies of answer papers will be supplied to the candidates on submission of application under RTI Act. Applications under RTI Act for supply of photo copies of answer papers will be entertained in the following manner :

- a) **Candidates, who wish to have the copies of answer papers supplied are required to pay a fee of Rs.25/- per paper with key plus Rs.10/- towards fee for application under RTI Act in the post office accounts** and submit their applications through the Division/Unit concerned along with the receipt for payment of fee in original. In turn, the Regional office(s) will prepare a consolidated list in the first week of March-2012. The heads of regions/divisions/units should also send a copy of the list by e-mail to cpmgre@gmail.com.
- b) The period of preservation of answer paper will be in accordance with the instructions issued from time to time i.e one year from the date of declaration of this result. Therefore applications received after one year for supply of photo copies of answer paper will not be entertained.

- c) Photo copies of answer paper will be supplied only to the candidates who appeared for the examination. **Therefore the candidates should invariably intimate their OMR Kit No. & Roll Numbers in the application under RTI Act.**
