Sub Result of LDCE (LGO) Examination 2011 for promotion to the cadre of PAs/SAs held on 16.10.2011

I am directed to send herewith the result of the Limited Departmental Competitive Examination for LGOs for promotion to the cadre of PAs/SAs held on 16.10.2011.

2. The Division wise information showing (i) vacancy position (ii) names of the candidates declared successful (arranged in order of merit on the basis of total marks obtained in the LGO Examination 2011 for appointment as PAs/SAs) and (iii) names of surplus qualified candidates are given in Annexure-I to this letter.

3. The selection of the candidates is based on the following eligibility criteria for qualifying in the Examination.

OC Candidates	40% marks in each paper
SC/ST candidates	33% marks in each paper

4. The information relating to the names of the candidates, their Roll Nos. and categories have been shown on the basis of information furnished by the concerned Divisions. In case any mistake in the names and other particulars of the candidate(s) is noticed later on, the same may please be corrected and the corrections may be intimated to this office also. In case, subsequently if it is found that any of the selected candidate(s) was not eligible to take the examination under the existing rules or instructions on the subject or for any other reasons or in case any mistake is found with regard to announcement of the result of any candidate for any reason whatsoever, his/ her name will be deleted from the list of successful candidates. This result is also subject to any change in the merit list of selected candidates due to future re-totalling and verification of answer books or any reason in accordance with the existing rules and instructions on the subject.

5. Allotment of surplus OC candidates has been done purely on the basis of merit to their neighbouring unit subject to their willingness to

work in the Division to which allotment is made. A formal willingness in writing in respect of surplus qualified OC candidates to work in the Division to which they are allotted may be obtained before their appointment and be kept on record. Cases of unwilling surplus qualified candidates may please be reported to this office for further necessary action. The cases of surplus qualified SC/ST candidates will be decided later after the process of review of failed SC/CT candidates of concerned Division is completed.


6. Provisional candidates: The Head of the concerned unit is requested to immediately finalise the case and such cases should not be kept pending for long time except in very exceptional and unavoidable circumstances so that the provisional candidates may not have to wait for the result inordinately. It may also be ensured that no provisional candidate is given appointment without regularisation of the candidature. Their cases should be considered in light of the instructions contained in Directorate letter No. 7/31/63-SPB-II dated 25.6.1965.

7. It is informed that the names of the candidates have been arranged in order of merit. In respect of candidates who got equal marks in the total, Divisional Heads are requested to arrange their position in the merit list according to their inter se seniority as per instruction existing on the subject and intimate the same to CO.

8. Verification and re-totalling of answer papers of Paper-I to II of all the candidates has been carried out by this office and photocopies of Answer Papers will be supplied to the candidates for submission of application under RTI Act. Therefore, requests for re-totalling will not be entertained. Applications under RTI Act for supply of photo copies of Answer Papers will be entertained in the following manner.


- a) Candidates, who wish to have the copies of Answer Papers supplied, are required to pay a fee of Rs.25/- per paper with key + Rs.10/- towards fee for application under RTI Act in the Post Office accounts and submit their applications through the Divisional Office concerned along with the receipt for payment of fee in original. Divisional Office will prepare a consolidated list and send it in the 2nd week of March 2012.
- b) The period of preservation of Answer papers is one year from the date of declaration of this result. Therefore, applications received after one year for supply of photocopies of Answer Papers will not be entertained.
- c) Photocopies of Answer Papers will be supplied to the candidates only who appeared fore the examination. Therefore, the candidates should invariably intimate their Roll Number in the application
