Applications are invited from Indian Nationals in the Proforma (Annexure-I) for Direct Recruitment of meritorious sportspersons from open market under **SPORTS QUOTA** for the vacancy years upto 2020 to the following Group 'C' posts in Punjab Postal Circle.

- i) Postal Assistant (PA) in Post Offices/SBCO
- ii) Sorting Assistant (SA) in Railway Mail Service
- iii) Multi-Tasking Staff (MTS) in Post Offices/Postal Accounts Office

The recruitment process will be based on the guidelines issued by the Department of Personnel and Training, Government of India vide Memo No. 14034/01/2013-Estt. (D) dated 03-10-2013 and instructions issued thereto.

Educational and Other Qualifications:

- (i) Postal Assistant / Sorting Assistant:
 - (a) Candidates must have passed 12th Standard or equivalent from a recognized Board or University.
 - (b) Candidates will be required to furnish certificate of Basic Computer Training from a recognized Computer Training Institute <u>before</u> <u>issuance of appointment letter</u>. Computer Training Certificates from Central Government / State Government / University / Boards etc. will also be accepted. This requirement of Basic Computer knowledge certificate is relaxable in cases where a candidate has studied computer as a subject in matriculation or Class XII or higher educational qualification and in such cases a separate certificate will not be insisted upon.

(ii) Multi-Tasking Staff:

- (a) Candidates must have passed 10th standard pass from a recognized Board.
 - (b) Knowledge of local language of the concerned State or Union Territory. The candidate should have studied local language at least upto 10th standard.

Note:

- (i) As per Ministry of Human Resource Development Notification dated 10-06-2015 published in Gazette of India all the degrees/ diplomas /certificates awarded through Open and Distance Learning mode of education by the Universities established by an Act of Parliament or State Legislature, Institutions Deemed to be Universities under Section 3 of the University Grant Commission Act 1956 and Institutions of National Importance declared under an Act of Parliament stand automatically recognized for the purpose of employment to posts and services under the Central Government provided they have been approved by the Distance Education Bureau, University Grants Commission.

10. **METHOD OF SELECTION**: Selection of the candidates will be made on educational and sports qualification and subject to fulfillment of prescribed conditions.

Meritorious Sportspersons will be selected for appointment based on the instructions contained in the Department of Personnel & Training OM no.14015/1/76-Estt. (D) dated 04-08-1980 and as amended from time to time and consolidated instructions issued by DOPT vide OM No. No.14034/01/2013-Estt. (D) dated 03-10-2013.

The order of preference is as under:-

- a) First Preference: Candidates who have represented the country in an INTERNATIONAL COMPETITION with the clearance of the Department of Youth Affairs and Sports.
- b) Second Preference: Candidates who have represented a State / Union Territory in the SENIOR OR JUNIOR LEVEL NATIONAL CHAMPIONSHIPS organized by the National Sports Federations recognized by the Department of Youth Affairs & Sports or National Games organized by Indian Olympics Association and have won medals or positions up to 3rd place. Between the candidates participating in Senior and Junior National Championships / games, the candidates having participated and won medal in Senior National Championship gets preference.
- c) Third Preference: Candidates who have represented a University in an INTER-UNIVERSITY COMPETITION conducted by Association of Indian Universities / Inter-University Sports Board and have won medals or positions up to 3rd place in finals.
- d) Fourth Preference: Candidates who have represented the State Schools in the NATIONAL SPORTS / GAMES FOR SCHOOLS conducted by the All India School Games Federation and have won medals or positions up to 3rd place.
- e) Fifth Preference: Candidates who have been awarded National Award in physical efficiency under National Physical Efficiency Drive.
- f) Sixth Preference: Candidates who have represented a State / Union Territory / University / State School Teams at the Levels (b) to (d) above but could not win a medal or position, in the same order of preference.

- Note 1: In the event of tie those who have secured a higher position or won more than one medals will be given the preference.
- Note 2: Participation in individual and team event / item will be given the same preference.
- Note 3: No preference will be given for winning more than one medal / position.
- Note 4: In case of any doubt the status of a tournament, the matter will be decided by the Department of Personnel & Training in consultation with Department of Sports and Youth Affairs.
- Note 5: The decision of competent authority i.e. Chief Postmaster General, Punjab Circle will be binding on all.

11. DISQUALIFICATION:

- Person who has entered into or contracted a marriage with a person having a spouse living; or
- Person who having a spouse living, has entered into or contracted a marriage with any person, shall not be eligible for appointment to said posts.

Provided that Central government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

12. DISCLAIMER:

- (i) Success in the Proficiency in the game / Ground (field trial) confers no right to appointment unless Department is satisfied after such enquiry, as may be considered necessary, that the candidate is suitable in all respect for appointment to the post.
- (ii) In case suitable candidates are not available in any of the above Games / Sports, the Department of Posts will reserve its right not to consider such games / sports.
- (iii) The Department of Posts reserves the right to cancel this recruitment process without assigning any reason.
- (iv) The vacancies notified are subject to change without assigning any reason and Department reserves the right to cancel the recruitment.
