In view of Judgment Order of Hon'ble Supreme Court and approval of Directorate for implementation of the Judgment, a committee was constituted to work out a strategy for segregation of the candidates as tainted and non-tainted.

Accordingly, a list of suspicious tainted candidates was published on 29.01.2021 vide letter referred above. In the said list, total 73 candidates were declared as suspicious tainted whose signature variation was found. These candidates were called to this office on 19.02.2021 for submission of Specimen Signature for onward submission to CFSL. The cases of the candidates who submitted Signature specimen were given to CFSL for further verification.

Accordingly, verification report of CFSL in respect of following candidate has been received vide letter No. CFSL (PUN)/ 434/DOC/ 88/22/DXP-C-122/21/1703 dated 08.06.2023. CFSL has opined that, signatures/ writings of the candidate on original documents and specimen signatures/ writings are written by one and same person.

Hence, the above candidate is treated as 'non-tainted' candidates and considered for completion of further appointment formalities subject to fulfillment of prescribed conditions for appointment. The candidate is allotted to the same Division/office where he was allotted

earlier. Concerned Region/Division will take appropriate action for issue of letter to the candidate by 27.06.2023 and complete appointment formalities and joining by 05.07.2023. Instructions issued in this regard by the Circle Office vide letter No. Rectt/2/SLP 22969-22976/2019 dated 29.01.2021 may be followed scrupulously by concerned appointing authorities. Concerned Division is requested to collect the dossier of the candidate from this office.
