In view of Judgment Order of Hon'ble Supreme Court and approval of Directorate for implementation of the Judgment, a Committee was constituted to work out strategy for segregation of the candidates as tainted and non-tainted.

Accordingly, a list of suspicious tainted candidates was published on 29.01.2021 vide letter referred above. In the said list, total 73 candidates were declared as suspicious tainted whose signature variation was found. These candidates were called to this office on 19.02.2021 for submission of Specimen Signature for onward submission to CFSL. CFSL had again requested for specimen signature and writings in respect of some candidates. The candidates who failed to attend this office again for providing specimen signature and writings on 29.03.2022, 21.04.2022 were again requested to attend this office on 05.05.2022, 15.06.2022, 05.08.2022 and 03.01.2023 intimating that failure to attend this office will be presumed that you are not willing to join the post and hence candidature will be cancelled.

Accordingly, following candidate neither attended this office on above mentioned dates and nor submitted any representation till date. Hence, candidature of following candidate is hereby cancelled:
