In view of Judgment Order of Hon'ble Supreme Court and approval of Directorate for implementation of the Judgment, a committee was constituted to work out strategy for segregation of the candidates as tainted and non-tainted.

Accordingly, list of suspicious tainted candidates was published on 29.01.2021 vide letter referred above. In the said list, total 5 candidates were declared as suspicious tainted whose photo variation was found. These candidates were called to this office on 19.02.2021 for submission of their photos for onward submission to CFSL. The cases of the candidates who submitted their Photos were given to CFSL for further verification.

Accordingly, verification report of CFSL in respect of following candidates is received vide letter No.CFSL(P)/206/DFD/29/2021/1089 to CFSL(P)/206/DFD/31/2021/1091 dated 16.03.2022. CFSL opined that photo of these candidates on original documents and on specimen documents are one and same person.

Hence, these candidates are treated as 'non-tainted' candidate and considered for completion of further appointment formalities subject to fulfillment of prescribed conditions for appointment. Concerned Divisions are requested to collect the dossiers of the candidates from this office.
