Based on the results of Combined Graduate Level Examination (CGLE), 2016, you have been nominated by Staff Selection Commission (SSC) for appointment as Inspector Posts in Department of Posts in Level 7 of Pay Matrix. A list of candidates nominated by Staff Selection Commission is enclosed as Annexure – I.

- 2. Candidates will be allocated to one of the 19 Postal Circles for appointment as 'Inspector Posts', where vacancy exists, a list of which is at Annexure II. Thereafter, the concerned Postal Circle will complete pre-appointment formalities and issue offer of appointment to the candidates allocated to that Postal Circle. The following shall be the criteria for allocation of Postal Circles.
  - a) A candidate shall be allocated to a Postal Circle on the basis of her/his merit(rank), order of preference (option), and vacancy available at her/his turn in the category she/he has been selected.
  - b) All such candidates who do not give order of preference or provide limited preference and are not allocated to any of the Postal Circle mentioned in their limited preference, shall be allocated to nearby Postal Circle from her/his home state (as per address available in their dossier) subject to availability of vacancy in the category she/he has been selected, after allocation of Postal Circle to all other candidate who have provided complete order of preference.

<u>Note:</u> Nearby Postal Circle shall be determined by road distance between Postal Circle headquarter of her/his home state (as per address available in their dossier) to headquarter of the Postal Circle where vacancy exists.

3. The Postal Circle wise and Category wise vacancy available in 19 Postal Circles are enclosed as Annexure – II. The candidates are requested to provide their order of preference for allocation to Postal Circle. The candidate who do not provide order of preference or provide limited preference will be at disadvantage, as they will be allocated

as per criteria 2(b) above. Therefore, candidates are requested to provide order of preference for all the Postal Circle in which vacancy exists in the concerned category.

- 4. Option once exercised shall be final and candidates will be allocated to Postal Circles as per criteria noted in para 2 above. No request for revision of order of preference or change of Postal Circle shall be entertained.
