Sub: Filling of the post of Sports Development Officer in CO, Patna on deputation and tenure basis.

The post was advertised for filling up from amongst the eligible officials of Bihar Circle vide this office letter of even no. dated 6.1.2012 and re-notified dated 29.1.2013, 22.4.2013 and 19.9.2014 to fill up the post of Sports development officer in the pay Scale of Rs.5200-20200/- with Grade pay of Rs. 2800/- on the deputation and tenure basis amongst the eligible volunteers in the Department of Posts. But no application from eligible official has been received. Therefore, it is again being re-notified to fill up the above mentioned posts.

The eligibility condition/qualification for the above post is indicated below:-

Deputation from among officials of the Department of Posts:-

- a.(i) Holding analogous post on regular basis in parent cadre or department; or
- (ii) With three years of service in the grade rendered after appointment thereto on regular basis in the pay scale of Rs.5200 -20200/- plus grade pay of Rs. 2400/- or equivalent in the parent cadre or department; Or
- (iii) With five years of service in the grade rendered after appointment thereto on regular basis in the pay scale of Rs.5200/--20200/- plus grade pay of Rs.1900/- or equivalent in the parent cadre or department; and
- b. Possessing the following qualifications:-
 - (i). Certificate as a qualified technical official referee or umpire or coach in any game issued by **National Institute of Sports or respective National or International Institute of Sports or respective National or International Sports Federation;**
 - (ii). Organizational experience of at least two years in holding All India Postal or Posts and Telecommunications Regional Tournaments; and
 - (iii) have represented the Circle or Region for a minimum of **three time** in All India Postal or Posts and Telecommunication competitions or has represented Posts or Posts and Telecommunications or state in a National Championship.

Desirable:- Has been member of the Central or Circle Sports Board.


Note-1:- Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department or the Central Government shall ordinarily not exceed three years.

Note-2:- The maximum age limit for appointment by deputation shall be not exceeding fifty six years as on the closing date of receipt of applications.

It is, therefore, requested that wide publicity may be made to all concerned. Applications from suitable and eligible candidate supported by certificates and testimonials if so received in may be forwarded in the enclosed proforma, latest by, alongwith service particulars, Vig/disc clearance, and photocopy of C.R. dossier for the last five years with your recommendation of the candidate should also be sent.
