Public Notice

In continuation of Public Notice No. DA-19/25/2024-DA-DOP dated 29.04.2026, it is hereby informed that the booking of international mail to certain destinations was temporarily suspended due to the force majeure situation in the Middle East and the resultant disruption of air connectivity.

The situation has since improved, and alternative transit arrangements have been established. Accordingly, postal services to the countries listed in **Annexure-A** are hereby resumed with immediate effect. However, customers may experience delays in delivery beyond the service standards.

However, due to the continuing geopolitical situation, air connectivity and/or transit arrangements have not yet been restored for the countries listed in **Annexure-B**. Accordingly, postal services to these destinations shall continue to remain suspended until further notice. Customers who have already booked articles for the countries listed in Annexure-B, but whose articles have not yet been dispatched from India, may recall their articles by submitting a written application to the booking post office and claim a refund of the postage paid, provided that no other liability is accepted by the Department of Posts. This facility is applicable only to articles that are still lying in India and have not been transmitted abroad. Such articles lying at the Offices of Exchange may be returned to the booking office upon receipt of recall requests through the prescribed channel.

The situation is being monitored continuously, and postal services to the suspended destinations will be resumed as soon as suitable flight connectivity and transit arrangements are restored.
