2. A copy of the order dated 08.04.2021 issued by Chief Commissioner for persons with Disabilities (Divyangjan) is enclosed herewith for favour of information and necessary action in issue of posting orders to Physically Challenged officials.

3. **The official should accept / decline the promotion unconditionally in writing within the above mentioned date.** In case the official declines promotion, a letter declining the promotion unconditionally may please be obtained immediately and be forwarded to this office for its acceptance. No correspondence in this regard will be entertained. If he / she declines the promotion, they should note that they are not eligible for promotion to the cadre of LSG in Post Offices for a period of 1 (one) year either on regular or ad-hoc basis from the date of declination. **Further, the officials who decline promotion will not be considered for financial up-gradation under MACP scheme, if any due, as per the existing rules / instructions till they accept promotion.**

4. The officials may be informed that if they fail to tender unconditional declination within the date mentioned above or fail to join in the promoted post, their promotion will be treated as Deemed Declination and orders will be issued accordingly by this office.

5. No representation for re-allotment will be entertained before joining in the new post in the LSG Cadre in the Region allotted. Hence, representations received from the officials for re-allotment before joining in the promotional post need not be sent to this office.

6. If the official is drawing his/her pay in Level-5, Level-6 and Level-7 in the pay matrix of 7th CPC he/she is not eligible for any pay fixation under the provisions of FR 22(I) (a) (1). If the official is not drawing the pay in the levels of pay matrix referred to above may exercise his/her option for pay fixation under the provisions of FR 22(I) (A) (1) within one month from the date of assuming the charge in the promoted post.

7. These promotion orders are subject to re-verification of all the facts/information given by the Divisional Heads and the Divisional Heads should personally check up the correctness of the information submitted and discrepancy, if any, noticed in respect of any official, the same should be reported to C.O. before issuing promotion orders.

8. Further, it is to intimate that this office vide letter No. ST-II/11-2/1/2017 dated 11.01.2022, identified 146 Non-upgraded HSG-II posts and assumed that the same were deemed to be in the LSG cadre. Instructions were issued to the Regions to fill up the Non-upgraded HSG-II posts with the LSG cadre officials.

9. Directorate vide letter No. 25-04/2012-PE-I dated 22.07.2022 clarified that the additional (new) posts of LSG, HSG-II, HSG-I & HSG-I (NFG), allocated to the Circles after the Cadre Restructuring, which have not been created by the Circles due to unavailability of eligible officials in the feeder grades, shall remain in the lowest grade i.e. Postal Assistant, while ensuring that the total sanctioned strength of PA, LSG, HSG-II, HSG-I & HSG-I (NFG), must not exceed the total number of posts in these grades.

10. Hence, suitable instructions may be issued to the Divisions that the officials who are working in Non-upgraded HSG-II posts may be posted in LSG posts immediately if vacancy available. If vacancy is not available, posting may be issued as and when a LSG post falls vacant within the Division.

11. 




