

The officials may exercise option for fixation of pay under provision of FR22(1)(a)(1), if they were not granted MACP-II/MACP-III previously, within one month from the date of assumption of charge in the promoted post.

These promotions orders are subject to re-verification of all the facts/information given by the Divisional Heads and Divisional Head personally check up the correctness of the information submitted if any discrepancy in respect of the official should be reported to Circle Office before issuing promotion orders.





2. The promotion of the officials will take effect from the date on which the officials actually assume the charge. The service rendered by the officials as HSG-I in the same office prior to their promotion as HSG-I (NFG) will also be counted for tenure. Sufficient care may be taken to ensure

that there shall not be two officials of HSG-I(NFG) cadre in the same office. Wherever one HSG-I(NFG) and one HSG-I official are working in the same office and HSG-I official is working as the Postmaster at present, HSG-I(NFG) official may be designated as the Postmaster and the other HSG-I official as DPM of the office.

3. In respect of promotion against temporarily re-deployed posts, specific posts/offices need not be identified. The officials promoted against redeployed posts may be transferred on completion of tenure as a part of HSG-I transfers while keeping in view the instructions herein above and dates of redeployment in Memo No.Q-25/2/2020-PE-I dated 05.08.2020. Regions may take up proposal with C.O for temporary up-gradation/down-gradation of HSG-I(NFG) Posts in case any issues arise during the Rotational Transfers, 2021.

4. Officials promoted on regular basis are entitled to exercise an option for fixation of pay on promotion under FR-22(1)(a)(i) on the date of promotion or on the date of accrual of next increment in the scale of pay in the lower post. The option in this regard should be exercised within one month from the date of promotion. Option once exercise is final.


5. The appointing authority reserves the right either to modify or cancel the promotion, if the official is found ineligible for promotion as HSG-I (NFG).

6. The officials should accept/decline the promotion unconditionally in writing within one month from the date of issuance of this letter. In case the official decline promotion, a letter declining promotion unconditionally may please be obtained and forwarded to this office immediately.

7. In the case of officials declining the promotion, no fresh offer of appointment on promotion either on regular or Adhoc basis shall be made for a period of one year from the date of refusal of promotion or till a next vacancy arises, whichever is later. On the eventual promotion to the higher grade, such Government Servant will lose seniority vis-à-vis his juniors promoted to higher grade earlier.

8. In case any Vigilance/ Disciplinary case, of the type referred to in OM No.22011/02/86-Estt (A) dated 12.01.1988 and DoP&T circulated vide Directorate memo No. 25-19/88-SPG dated 04.05.1988 (subsequently) revised vide DoP&T Memo No.220011/4/91-Estt(A) dated 14.09.1992 circulated vide Directorate Memo No. 25-19/88-SPG dated 13.10.1992 is pending against any of the above mentioned officials, they should not be relived for posting without obtaining specific orders from this office. **The officials, against whom any punishment is current, should not be promoted before expiry of currency of punishment. A report in this regard should be submitted to this office immediately.**

9. If the promoted official refuse the promotion before becoming entitled to a financial upgradation, no financial upgradation under MACP shall be allowed as such he/she has not been stagnated due to lack of opportunities. If however, financial upgradation has been allowed due to stagnation and he/she subsequently refuses the promotion, it shall not be a ground to withdraw the financial upgradation. He/she shall, however not be eligible to be considered for further financial upgradation under MACP, till he/she agrees to be considered for promotion again and the second

and the next financial upgradation shall also be deferred to the extent of period of debarment due to the refusal.

10. It should be ensured that, no Vigilance/ Disciplinary case is pending against the officials, while effecting HSG-I (NFG) Promotion. Relief of the officials to the promotional post wherever necessary should be ordered by the Heads of Division/ Unit only after satisfying the above conditions.







The Financial Up-gradation under MACP scheme will be on the following terms and conditions as contained in OM No. 35034/3/2008-Estt(D) dated 19.05.2009 of Ministry of Personnel Grievances and Pensions (Department of Personnel and Training, New Delhi) and relevant orders issued from time to time by the Postal Directorate.

1. The Financial Up-gradation is non-functional basis and therefore, the cadres of the officials will remain unchanged. There will be no change of designation etc., as such their seniority will be continued in the existing cadre only.
2. The Financial Up-gradation granted under the MACP scheme is final and no pay fixation benefit shall accrue at the time of regular promotion i.e., posting against a functional post in the higher grade/cadre.
3. On Up-gradation, the Government Servant has an option under FR-22(1) (a) (1) to get his/her pay fixed in the higher post/grade pay either from the date of his promotion/up-gradation or from the date of his/her next increment viz; 1st July of the year. He/she should exercise the option within one month from the date of issue of this order.
4. Any over payment found at later date for any reason is liable to be recovered from pay and allowances without any limitation.
5. No stepping up of pay in the pay band or grade pay would be admissible with regard to junior getting more pay than senior on account of pay fixation under MACP Scheme.

A declaration from the officials concerned to the effect that he/she has no objection to recover the excess payment of amount, if any, due to irregularity noticed at a later date on grant of financial up-gradation under MACP should be obtained and kept on record by the DDO concerned.

The above orders are subject to modifications on the instructions issued from time to time in this regard by the Directorate.
