2. The Postmasters General, Kurnool/ Vijayawada/Visakhapatnam Region are requested to issue necessary posting orders to the officials immediately.

3. VIGILANCE/DISCIPLINARY CASE, IF ANY:

In case any vigilance/ disciplinary case, of the type referred to in OM No. 22011/2/86-Estt.(A) dated 12.01.1988 from DOP&T circulated vide Directorate memo No. 25-19/88-SPG dated 04.05.1988 (subsequently) revised vide DOP&T Memo No. 22022/4/91-Estt.(A) dated 14.09.1992 circulated vide Directorate memo no. 25-19/88-SPG dated 13.10.1992 is pending against the officials, the official should not be relieved for posting without obtaining specific orders from this Office. The Promotion of the official should not be withheld on the mere ground that disciplinary action is contemplated, except the circumstances when the official is under suspension or a charge sheet has been issued to the official or prosecution for a criminal charge is pending against the official. The official against whom any punishment is current except censure and recovery of loss amount should not be promoted before expiry of currency of punishment. A report in this regard may be submitted immediately.

4. The above officials should accept/ decline the promotion unconditionally in writing within one month from the date of issuance of these orders. In case the official declines promotion, an unconditional declination letter may please be obtained immediately and to be forwarded to this office for its acceptance. If any

official declines promotion, he/she should note that he/she is not eligible for promotion to the cadre of LSG (Accountant) in Post Offices for a period of 1 (one) year either on regular or adhoc basis from the date of declination. Further, the official who declines promotion will not be considered for financial upgradation under MACP Scheme, if any due, as per the existing rules/instructions till they accept promotion.

5. OPTION FOR FIXATION OF PAY:

If the official is already drawing pay in the pay scale of Level-5 in the pay matrix as per 7th CPC, he/she is not eligible for any pay fixation under the provisions of FR-22(I)(a)(1). If the official is already not drawing the pay in the level of Pay Matrix referred to above, he/she may exercise an option for choosing date for fixation of pay under FR-22(I)(a)(1) *within one month from the date of assumption of charge on promotion.*

6. The date of joining of officials in the cadre of LSG (Accountant) in Post Offices may please be intimated promptly to this office.

7. These promotion orders are subject to re-verification of all the facts/information given by the Divisional Heads and the Divisional Head should personally check up the correctness of the information submitted and discrepancy, if any, noticed in respect of any official, the same should be reported to C.O. before issuing promotion orders.

3. The official should accept / decline the promotion unconditionally in writing within the above mentioned date. In case the official declines promotion, a letter declining the promotion unconditionally may please be obtained immediately and be forwarded to this office for its acceptance. If he / she declines the promotion, they should note that they are not eligible for promotion to the cadre of LSG in Post Offices for a period of 1 (one) year either on regular or adhoc basis from the date of declination.
